Built before 1968, the house was carefully and lovingly renovated in 2009, preserving its original, traditional features that give it a distinctive charm and a sense of history. Surrounded by unspoiled nature, the property provides a genuine Mediterranean atmosphere on a spacious 1,430 m2 plot. At the entrance, a magnificent centuries-old oak tree welcomes you, inviting you to relax in its shade.

The house is spread over two floors. The ground floor includes an entrance hall, a bathroom, a cozy living room with a fireplace, a kitchen with a dining area, and one bedroom. All rooms have direct access to the garden, while the kitchen opens onto a charming summer kitchen

with a fireplace—perfect for enjoying long evenings with family and friends.

Upstairs, there are two additional bedrooms, a bathroom, and a spacious covered terrace overlooking the greenery and peaceful surroundings.

The fully fenced garden ensures privacy and offers excellent amenities: a centrally positioned 32 m² swimming pool with a shallow area for children, an outdoor shower, a garden house, an additional summer kitchen with a social area, parking spaces, and a beautifully maintained lawn.

For year-round comfort, the house features gas central heating and a fireplace, while air conditioning units provide cooling during the summer months. The façade was renovated three years ago.
